

## LEGAL RULES OF "LA FINCA RESORT TE CUIDA" "TIEMPO DE CUIDARTE" PROMOTIONAL CAMPAIGN

#### 1.Organiser.

Urbanizadora Villamartín, S.A. whose registered address is Avda. de las Brisas, 8 03189 Orihuela Costa (Alicante), Tax ID A-28222602 is planning to carry out a promotional campaign consisting of a prize draw, which will be subject to the following legal rules.

The promotional campaign is called: "Tiempo de Cuidarte. La Finca Resort Te Cuida" (Time to take care of yourself. La Finca Resort takes care of you).

The campaign will be advertised in both online and offline media and will feature in Facebook, Instagram and Linkedin profiles.

### 2. Dates of the competition and geographic scope.

The promotion will finish on 15 July at midnight. No entries will be accepted after this date.

Urbanizadora Villamartín, S.A. reserves the right to postpone or to extend the competition period in case of force majeure, and reserves the right to interpret these legal terms and conditions.

If force majeure makes it necessary to postpone, change, cancel or repeat the competition, this will be announced on the website www.lafincaresort.com and on official social media profiles and any such changes will be publicised to the same extent as the competition.

The promotion is nationwide and is a purely online competition.

#### 3. Purpose.

The purpose of the competition is to promote the La Finca Resort brand and to reward public and private sector employees who are working during the Covid-19 pandemic and who are clearly of service to the community. Such workers may enter the prize draw by completing the steps and registering to take part on www.lafincaresort.com

#### 4. Free of charge.

Competition entry is free of charge. There are no requirements to purchase products or services in order to take part, nor will winners be required to pay any amounts or sums to obtain the prizes available.

#### 5. Participation requirements and mechanism.

The competition is open to anyone over the age of 18 years who is a tax resident in Spain.

The competition is not open to employees of Urbanizadora Villamartín or of the companies in its business group, their relatives or anyone who has been involved, directly or indirectly in the preparation and development of the promotion.

Anyone fulfilling the requirements of the promotional campaign may enter the competition, but proven fake profiles will not be eligible for prizes.

Participation through agents or third parties is forbidden and participants may not use multiple identities.

Winners must prove they are working to serve the community in connection with the Covid-19 pandemic and the companies by which they are employed.

#### Mechanism of the promotion:

To take part, users must enter their details in a form posted on the website: www.lafincaresort.com/en/time-care and must be followers of at least one of our social media profiles: Facebook, Instagram, Linkedin or Twitter.

To ensure the success of the promotion, Urbanizadora Villamartín, S.A. reserves the right to make changes during the campaign in order to improve its progress or in the event that anything prevents its proper operation.

#### 6. Choosing the winner and type of prize draw.

An online tool will be used to select winners at random from among all the participants who have entered their details. The organiser reserves the right to:

- Delete offensive comments about the organiser or other participants and eliminate the authors from the competition.
- Delete anyone who it considers is misusing, engaging in fraud or abusing the competition.
- Interpret the rules and conditions in situations in case of disputes. The organiser's decisions are final and may not be appealed.
- The deadline for entries is 15<sup>th</sup> July 2020.

Winners will be chosen randomly and selected every Friday at 10 am until the participation deadline. Each week's winners will be contacted by telephone on the numbers provided at registration or through their social media profiles. If the winner cannot be notified using the contact details within three days, or the winner refuses to accept the prize, it will be awarded to runners-up.

Participants who are not lucky enough to win will be entered for subsequent prize draws every Friday with the details they entered. Participants who would rather not be included in further prize draws, should send written notice of this to leave the competition.

#### 7. Value and nature of the prize on offer.

Every week, the organiser will announce the result of the prize draw on the website www.lafincaresort.com and on the Facebook and Instagram pages of La Finca Resort. Winners will be contacted on the same day and no appeals or objections to the decision will be accepted. The winner is entitled to reject the prize but under no circumstances will it be exchanged for another prize or for cash.

Every week, there will be a prize draw for five stays for five winners La Finca Resort, which will consist of:

- One night's accommodation and breakfast.
- Access to the spa

Use of the prize is subject to availability on the dates required and must be notified and booked with La Finca Resort.

A total of 100 one-night hotel stays for two people (bed and breakfast) will be given away. The organiser will determine the date on which the prize may be used up until 30<sup>th</sup> October 2020, subject to availability.

#### 8. Disclaimer for network faults.

The organiser accepts no liability for any malfunction of the internet that hinders the normal operation of the competition for causes outside the control of the company and particularly when due to external actions in bad faith.

# 9. Information about personal data processing (in compliance with Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016).

9.2. The personal data is processed to manage the data subject's participation in the competition called "Tiempo de Cuidarte. La Finca Resort Te Cuida", its operation and to designate the winners.

The data will also be necessary for publication on the website, social networks and in other publications.

9.3. Data storage periods: Data identifying participants will be saved throughout the promotional period and for the legal terms which apply to be able to send information about La Finca Resort's activities and events, provided that the participant has given express consent.

9.4. Legal basis for the processing: the grounds for processing the data is the consent granted by the participant when entering the competition who therefore accepts these legal rules. However, withdrawal of this consent will not impact the legality of past processing.

9.5. International data sharing and transfers: data will not be shared with third parties and no international data transfers are foreseen. Urbanizadora Villamartín, S.A., as the data controller, may access and store the data (within the European Union) to offer the services of its platform to the customer within the framework established and for this purpose only.

9.6. Participants' rights Data subjects may exercise their rights to access, correction, erasure, portability and limitation or opposition to the data in the cases and with the scope established in the GDPR EU 2016/679. Data subjects also have the right to withdraw their consent at any time. To exercise these rights, data subjects can write to Urbanizadora Villamartín, S.A. Using any of the social network communication channels, the website or email.

#### **10. Penalties in case of fraud.**

Fraud is defined as the use of independent platforms or applications to enter the competition multiple times, as well as conduct we suspect of being abusive or malicious.

If any of these practices are detected, the entries will be deleted.

Urbanizadora Villamartín, S.A. reserves the right to take legal action against persons who engage any type of activity that could be construed as manipulation or falsification of the competition.

Urbanizadora Villamartín, S.A. waives all liability for damage caused by temporary lack of availability or continuity of the operation of the application used to enter the competition, fraudulent use attributed and when accessing the various pages and sending data to participate over the Internet.
